## PURPOSE

### Roles and Responsibilities of IICMR MBA Department

### Roles and Responsibilities of IIMM

1. IIMM will provide qualified trainers for OSCM related certification.
2. Facilitate coordination with trainers by providing details well in advance.
3. Facilitate internship and placements of students by sharing company data and nature of a requirement.
4. Provide a system of concurrent evaluation for students and remedial courses if needed.
5. Arrange Field and industrial visits.

## **A. OBJECTIVES**

The goal of this collaboration cooperation is to foster and provide opportunity for corporate exposure, experience and facilities advancement of knowledge on the basis of reciprocity and mutual benefit.

- a) Joint proposal ,engagement in training programmes from IICMR and IIMM.
- b) Organization of industrial visits for the students of IICMR. MBA
- c) Exchange of information on teaching & learning material relevant to programme.
- d) Internship and training opportunities for the students of IICMR MBA

The terms of any financial agreements will be subject to separate agreement (s) made on a case-by-case basis.

## **B. OUTCOME OF THE MOU**

The outcome of the collaboration to deliver following key outcomes:

- Development of a mechanism for opportunities for internships placement for students.
- Continuous promotion of industry exposure for the student by providing industrial visit and corporate mentoring.

## **C. Industrial Visits**

IIMM will help and facilitate industrial visits, to study manufacturing and service operations, to the students of IICMR MBA, industrial visit with same day return will be always recommended.

## **D. Co-ordination**

It is mutually agreed that parties to this agreement will specify and nominate one person as a point of contact for the purpose of coordinating the proposed activities mentioned in this agreement.

## **E. Entire Agreement**

This memorandum, its attachments and the applicable statements of work constitute the entire agreement between party A and party B regarding the subject matter of this memorandum superseding any and all prior oral and written understandings.

## **F. Tenure and Termination**

This MoU would come in force from the date it is signed by the parties to agreement and will remain valid for a period of two years from its commencement. Once the agreement stands terminated, either of the party will not claim any financial or other losses from each other.

## **G. Periodic Review**

The parties agree that the person's nominated herein below as the point of contact for each party (or their respective nominees) shall meet at least once in a year or in between if required.



## H. Costs

Financial implications of the programs/initiatives will be discussed case by case basis as required. Certification/Courses conducted by IIMM and IICMR will be mutually discussed as per the availability of students and faculty members and the cost involved in it.

## I. Warranty





## 3. Outcome of the Course:


- Students are well aware about the Supply Chain modules and subject core concepts.

## 4. Evaluation:


